## **Objectives and Investment Policy**

**Objective** The fund aims to maximise the current yield on your investment through providing efficient access to broad global credit market exposure by investing in a diversified pool of fixed income securities and instruments, using prudent investment management principles.

**Investment Policy** The fund is an actively managed portfolio which seeks to achieve its investment objective by investing at least 80% of its net assets in a diversified portfolio of fixed income instruments and securities (which are loans that pay a fixed or variable rate of interest) issued by governments or companies from around the world.

The average portfolio duration of this fund will be hedged and is expected to be between negative one year and positive one year based on the investment advisor's forecast for interest rates. The fund seeks to achieve this by entering into derivative transactions to effectively convert the fixed rate interest payments into floating-rate interest payments. Such derivatives may include interest rate swaps and interest rate futures. The derivatives return is linked to movements in the underlying assets.

Duration measures the sensitivity of the assets to interest rate risk. The longer the duration the higher the sensitivity to changes in interest rates.

The securities will be both "investment grade" and "non-investment grade. "Non-investment grade" securities are generally considered to be riskier investments but may pay a higher income.

The fund may invest substantially in emerging markets, which in investment terms are those economies that are still developing.

The fund may invest in instruments such as convertible bonds, including contingent convertible bonds, which are bonds that can be converted into shares.

The assets held by the fund may be denominated in a wide variety of currencies. The investment advisor may use foreign exchange and related derivative instruments to hedge or implement currency positions.



**Distribution Policy** This share class pays out a distribution of any investment income generated by the fund. You may elect for this to be reinvested into the fund. This share class seeks to pay out an enhanced source of income. This may involve the payment of charges and distributions out of capital which may reduce the value of your holdings and impact the potential for long term capital growth.

**Share Class Currency Hedging** This share class seeks to limit the shareholder's currency risk by reducing the effect of exchange rate fluctuations between the share class currency and any non-active currency exposures of the fund.

**Dealing Day** You can buy and sell shares on most working days in Dublin, exceptions to this are more fully described in the fund holiday calendar available from the Administrator.

In addition to the risk captured by the indicator, the overall fund value may be considerably affected by:

Credit and Default Risk A decline in the financial health of an issuer of a fixed income security can lead to an inability or unwillingness to repay a loan or meet a contractual obligation. This could cause the value of its bonds to fall or become worthless. Funds with high exposures to non-investment grade securities have a higher exposure to this risk.

Currency Risk Changes in exchange rates may cause the value of investments to decrease or increase.

**Derivatives and Counterparty Risk** The use of certain derivatives could result in the fund having a greater or more volatile exposure to the underlying assets and an increased exposure to counterparty risk. This may expose the fund to larger gains or losses associated with market movements or in relation to a trade counterparty being unable to meet its obligations.

**Emerging Markets Risk** Emerging markets, and especially frontier markets, generally carry greater political, legal, counterparty and operational risk. Investments in these markets may expose the fund to larger gains or losses.

Interest Rate Risk Changes in interest rates will usually result in the values of bond and other debt instruments moving in the opposite direction (e.g. a rise in interest rates likely leads to fall in bond prices).

**Liquidity Risk** Difficult market conditions could result in certain securities becoming hard to sell at a desired time and price.

Mortgage Related and Other Asset Backed Securities Risks Mortgage or asset backed securities are subject to similar risks as other fixed income securities, and may also be subject to prepayment risk and higher levels of credit and liquidity risk.

The charges you pay are used to pay for the costs of running the fund, which include the marketing and distributing costs. These charges reduce the potential growth of your investment.


