Fund manager's commentary

The first quarter of 2025 brought havoc to the market. Inaugurated U.S. President Donald Trump immediately took actions to control global trade flows and imposed import tariffs, at the same time reducing support for Ukraine and cutting public spending. Meanwhile, Europe has rushed to increase defense spending. These factors negatively affected expensive US stocks and induced a rise in interest rates in Europe. Since the beginning of the year, US equity prices denominated in euros have fallen by 8.6 percent, the European government bond index has fallen by 1.2 percent, while corporate bonds have risen slightly. Conservative Luminor funds have avoided the big equity market shock and the result of the first quarter was positive.
